
2.1.6. ORGANISATIONAL CHART OF THE MANAGING AUTHORITY





Managing authority checks a conclusion by filling in a checklist and submits a payment application for payment of costs to the Ministry of Finance







DATA COLLECTION AND SECURITY ASSURANCE FUNCTION (ARTICLE 72(1)(E) OF THE CPR)

Managing authority

- establishes the procedures to ensure audit trail and documents storage;
- ensures that the electronic data exchange system is in place in accordance with the requirements established in Article 4 of the CPR;
- submits documents and information via the electronic data exchange system.

Intermediate body

- develops and administers the electronic data exchange system;
- prepares regulations of an electronic data exchange system and data security regulations;
- submits documents and information via the electronic data exchange system.

SUPPORT FOR THE MONITORING COMMITTEE (ARTICLE 72(1)(C), ARTICLE 75 OF THE CPR)

Monitoring Committee

- considers and approves project selection methodology and criteria, Programme changes, annual performance reports, Programme evaluation plan and amendments thereto;
- monitors and assesses implementation and progress of the implementation of BMVI and ISF programmes according to Article 40(1) of the CPR;
- considers and submits recommendations regarding accounts of an accounting year and redistribution of funds to projects and approval and amendment of plans of implementation of the Programme actions;
- performs other functions;

Managing authority

- performs the functions of the secretariat of the Monitoring Committee;
- prepares draft agendas of meetings of the Monitoring Committee, materials, all documents, draft meeting reports, draft decisions of the Monitoring Committee, organises meetings, etc.
