The implementation of SO1 has progressed towards achieving the objectives of the national programme.

9 out of 9 projects (LT/2017/PR/1111, LT/2016/PR/1121, LT/2018/PR/1123, LT/2016/PR/1211, LT/2019/PR/1212, LT/2016/PR/1311, LT/2016/PR/1312, LT/2020/PR/1112, LT/2020/PR/1122) were successfully completed by 30 June 2024.

NO1. National capacity

5 projects to adapt the national VIS to changes in the Visa Code, upgrade, in whole or in part, technical and communication equipment of working places at 51 visa services, install and maintain point to point lines with the Embassies of the Republic of Lithuania and 4 other consular offices, increase flow of transmitted data between them have been completed.

NO2. Union acquis

Seeking to improve the qualitative and quantitative performance indicators of Lithuania's visa services, 2 projects on training for consular staff have been carried out and completed.

SA1. Consular cooperation

In order to set up consular cooperation mechanisms between at least two Member States resulting in economies of scale as regards the processing of applications and the issuing of visas at consulates in accordance with the principles on cooperation laid down in the Visa Code, the MFA carried out and successfully completed a project "Broadening of representation at the Consulate-General of the RL in Almaty" (2 phases of the project).

With effect of the implementation of the SA1 from March, 2017 Lithuania represents Iceland for the purpose of examining visa applications and issuing short stay Schengen visas in Almaty, Kazakhstan.

For the purpose of issuing Schengen visas the Consulate-General of the RL in Almaty represents Estonia (since January 2012), Finland (since May 2012), Sweden (since June 2012), Norway (since June 2015) and Iceland (since March 2017).

There were no significant issues affecting the performance of the programme against the objectives set.

2 actions have been carried out under the programme. 5 out of 5 projects have been completed.

• Implementation of the national VIS

Project LT/2017/PR/1111 *Adapting NVIS to changes in the Visa Code* completed in 2019. Project LT/2020/PR/1112 *Development of the national VIS* started in 2019 and completed in April 2024.

• Upgrading of technical and communication equipment of working places at visa services

Prroject LT/2016/PR/1121 *Upgrading of technical and communications equipment of working places at visa services, Phase I,* completed in 2018.

Project LT/2020/PR/1122 Upgrading of technical and communications equipment of working places at visa services, Phase II, started in March 2020 and completed in April 2024.

Project LT/2018/PR/1123 *Purchase the leased line service* completed in 2020. Four international communications channels (leased lines) have procured: the MFA and the Embassy of the RL to the State of Israel (of 2 Mbps bandwidth); the MFA and Embassy of the RL to the USA and the United Mexican States (of 100 Mbps bandwidth); the MFA and the Permanent Delegation of the RL to NATO (of 100 Mbps bandwidth); the MFA and the Embassy of the RL to the Republic of India (of 10 Mbps bandwidth). The project helped the MFA to increase cyber security with the earlier mentioned four international communication channels worldwide also to ensure effective and uninterrupted internet connection between the MFA and four Embassies when there are internet censorship and difficulties with surveillance in those countries.

The following action was carried out under the Programme:

• Training for employees of visa services

Project LT/2016/PR/1211 *Training for employees of visa services, Phase I* completed in 2018. Project LT/2019/PR/1212 *Training for employees of visa services, Phase II* completed at the begining of 2023.

Since the state of emergency due to the COVID-19 pandemic in Lithuania was canceled only on 01.05.2022 the beneficiary (Ministry of Foreign Affairs) could not implement all planned project LT/2019/PR/1212 activities. The beneficiary informed the responsible authority about the situation and returned part of the funds (EU funds amount of 100,000 euros) received by way of pre-financing on 30 June 2022) without waiting for the end of the project.

The following action supported and carried out under the Programme:

• Broadening of representation at the Consulate-General of the RL in Almaty

In accordance with a project "Broadening of representation at the Consulate-General of the RL in Almaty" 1 consular officer position and 1 technical employee (filing clerk) were established and are maintained in the Consulate-General of Lithuania in Almaty, Kazakhstan, starting 2016. The project was split into two phases depending on the length of time covered.

A project LT/2016/PR/1311 Broadening of representation at the Consulate-General of the RL in Almaty, Phase I, completed in May 2019.

A project LT/2019/PR/1312 Broadening of representation at the Consulate-General of the RL in Almaty, Phase II, activities started in 2019 and completed on 28 February 2023.

Specific objective	2 - Borders

The implementation of SO2 has progressed towards achieving the objectives of the Programme.

20 actions were carried out up to the date of this report. 37 out of 37 projects successfully completed by 30 June 2024.

• NO1: EUROSUR

Projects contributed to the setting up 5 new local coordination centres, modernisation of NCC, 1 regional and 8 local coordination centres at the border with the Russian Federation and at the border with Belarus, to a reduction in the reaction time for border control, quality of analytical reports, increasing of the NSP-level situational awareness. 9 out of 9 projects are closed.

• NO3: Common Union Standards

Measures have to be implemented necessary to 1) automatically verify the physical and electronic protection measures of travel documents with the set-up and operation of the technical infrastructure for the connection to the ICAO PKD; 2) harmonise voice radio communication network with Poland and Latvia; 3) upgrade information system VRIS (2 phases). 4 out of 4 projects are closed.

• NO4: Union Acquis - Borders

The SBGS run a range of specialised and advanced courses to implement recommendations made in Schengen evaluations, improve skills and competences of border guards, increase number of officers who are comprehensively prepared to participate in operations coordinated by the EBCGA. 3 out of the 3 projects are closed.

- NO6: National capacity Borders To ensure proper control and monitoring of the borders taking into account the abolition of border checks at the internal border and strengthening of border checks and surveillance at the external border 17 projects have been completed. The SBGS acquired transport means, technical equipment for border surveillance, a virtual platform for the secure management of the closed network of the SBGS criminal intelligence units and classified information on external borders, service dogs and dog handling gear.
- The ISF BV top-ups for SIS, EES, ETIAS and IT systems in general were used solely for the purpose for which they were allocated in 2018 and 2019. As the delays in the delivery of EES and ETIAS disrupted the funding of the national projects, the SBGS defined a relevant milestone in the development of EES and, respectively, ETIAS for the closure of the projects under those ISF BV topups.
- **SA2: Frontex equipment** 1 Thermal Vision Vehicle (TVV), 1 coastal patrol boat (CPB), 1 Coastal Patrol Boat (CPB) and 1 RHIB Interceptor were purchased and put at the disposal of the EBCGA. 4 out of 4 projects are closed.

The implementation of SO2 has progressed towards achieving the objectives of the national programme. Lithuania will successfully integrate national IT architecture into Europe's interoperable large-scale IT systems, modernizing and digitalizing the EU external borders, enhancing security and facilitating travel into the EU.

There were no other than EES and ETIAS significant issues affecting the performance of the programme against the objectives set.

• Strengthen exchange of information among all the authorities responsible for external border surveillance by obtaining advanced electronic data processing and transmission techniques to maintain the National Situational Picture (NSP)

Project LT/2018/PR/2111 *To procure and modernise hardware for continuous information exchange* completed in Jan 2019. As a result, the NSP maintains with information on the status and the position of available assets, areas of operation and information on environmental conditions at the external border, all incidents related to illegal migration, cross-border crime, crisis situations as well as analytical reports, risk rating trends, regional monitoring.

• Development of national border surveillance system. All projects are finished.

LT/2017/PR/2121 *Installation of border surveillance systems* completed in Dec 2017. The border surveillance systems at the most vulnerable border sections with Belarus (*at Purvėnai, Druskininkai, Tribonys, Švenčionys and Pavoverė FSs,* 180.44 km) installed, **5 local coordination centres (LCC)** established.

LT/2016/PR/2122 Upgrading of border surveillance systems at Bardinai, Viešvilė, Lavoriškės and at Zagunis FSs completed in Oct 2019. As a result **2** LCC at the land border with the Russian (at Bardinai FS, 27.5 km; at Viešvilė FS, 30 km) and **1** LCC at the border with Belarus (at Lavoriškės FS, 22

km) modernised; The initialy planned upgrading of border surveillance system at Zagunis FS withdrawn in order to cover a longer section of Lavoriškės FS.

LT/2020/PR/2128 *Upgrading of border surveillance system at Lavoriškės FS, Phase II* completed in Dec 2019. The previously installed border surveillance system at the border with Belarus (33 km) fully renewed.

LT/2018/PR/2125 *Upgrading of border surveillance system at Plaškiai FS* completed in Dec 2018. A previously installed border surveillance system (24.5 km) and 1 LCC renewed.

LT/2019/PR/2126 *Upgrading of the border surveillance system at the Vileikiai FS* completed in June 2020. **1 LLC** renewed.

Project *Upgrading of the border surveillance system at the Padvarionys FS* completed in Aug 2021. 1 LLC renewed.

2 projects *Upgrading of the maritime border monitoring system, Phase I* and *Phase II* have been completed. As a result **a regional centre** (at the Coast Guard Frontier District in Kopgalis) and **2 maritime LCC** (at Palanga Fs and Neringa FS (backup in Juodkrante) renewed.

The results set up in the programme have been fully achieved.

Actions funded under national objective 2 - Information exchange

No funding priorities were planned under this national objective.

3 actions were carried out up to the date of this report. 4 out of 4 projects have been successfully completed.

• Implementation of the biometric data verification system, stage II

Project LT/2017/PR/2211 Implementation of the biometric data verification system (Phase II) completed in Nov 2018. Lithuania established SPOC infrastructure and national DV interface to fulfil the requirements of Commission decision C (2009) 7476 to have a robust communication infrastructure for regular inter-country communication covering DV certificate exchange. SPOC ensures full-fledged Extended Access Control for electronic Machine Readable Travel Documents (eMRTD) like passports, travel documents and residents permits. Competent authorities in the Member States are granted access to Lithuania's eMRTD while relevant authorities in Lithuania have access to biometric information stored in eMRTD of other Member States.

• Harmonisation of radio communication with Poland and Latvia through installation of the voice information communication networks integration equipment

Project LT/2020/PR/2222 Modernisation of the DMRCS, implementation of the radio interfaces with Poland and Latvia completed in 2021. DMRCS was updated by including new technological solutions. No joint voice information exchange channels have been set up with Poland and Latvia due to significant differences in the technological systems in each of the Member States.

The project progressed more slowly than planned due to the lengthy procurement process for buying licences.

• Upgrading of the main and the back-up centres of the information system VRIS

Project LT/2018/PR/2231 *Upgrading of the main and the back-up data centres of the VRIS, Phase I* completed in May 2019. The VRIS, based on joint information technology and telecommunications infrastructure, ensure stable data exchange among the national information systems and SIS, VIS, Foreigners Register and Interpol's database.

Project LT/2020/PR/2232 Upgrading of the main and the back-up data centres of the VRIS, Phase II completed in Oct 2020.

2 actions supported and carried out up to the date of this report. 3 out of 3 projects have been successfully completed.

• Specialised and advanced training of border guards aimed to improve professional competences and skills

Project LT/2016/PR/2311 Specialised and advanced training of border guards aimed to improve professional competences and skills, Phase I, completed in 2018.

Project LT/2019/PR/2312 Specialised and advanced training of border guards aimed to improve professional competences and skills, Phase II, completed in 2022. Training activities are brought in line with the sectorial qualifications frameworks (SQF) for border guarding.

• Implementation of the recommendations made in Schengen evaluations

Project LT/2019/PR/2321 completed in 2021. To implement SchEval recommendations, SBGS run training courses on managerial capability and communication in foreign languages related to both fulfilling of border guards daily duties and tasks and operational communication during joint operations.

The results set up in the programme have been achieved.

• Upgrading of software and hardware

LT/2018/PR/2421 completed in 2020. SBGS acquired hardware (236 pc) and software, fingerprint scanners (181), document scanners (181), SQL Server and Schengen Masterlist service for the document authenticity checks.

• Acquisition of technical means for border control

LT/2017/PR/2431 on procurement of portable thermal imaging cameras (229), night-vision devices (231) and of binoculars (200) completed in 2019.

6.2 Common monitoring and evaluation framework (Article 14(2)(f) of Regulation (EU) No 514/2014)

Monitoring and evaluation measures taken by the Responsible Authority, including data collection arrangements, evaluation activities, difficulties encountered and steps taken to resolve them.

Responsible authority (RA) as well as delegated authority (DA) have monitored the ISF common indicators and programme specific indicators as well as other project results. According to project agreements, every project has an ISF programme indicator (if applicable) that is planned to achieve and project performance indicators. In accordance with a pre-agreed payment application submission schedule, project promoter submits payment applications to a delegated authority and reports on the project performance indicators set in a project agreement as well as ISF common indicators and programme specific indicators (if applicable). Indicators and their achievement are monitored through the ISF information system (VORAS).

DA verifies payment applications while analysing project performance indicators provided in the payment application for the reporting period as well as ISF common indicator and programme specific indicator (if applicable). DA monitors the level of achievement of project performance indicators and ISF programme indicator (if applicable) while also considering indicator values provided in a project agreement. If the desired level of an ISF programme indicator and/or project performance indicator provided in a project agreement is not achieved, the delegated authority assesses the reasonableness of funding for such project, and can propose to reduce the funding to this project in accordance with the ISF programme's project administration and financing rules. There were no such problems in financial years 2023-2024. Project providers implemented projects consistently and smoothly, so it is expected that in accordance with the submitted project provider's payment applications, all the planned project performance indicators and ISF programme indicators will be achieved at the end of the project's implementation.

ISF programme monitoring revealed good cooperation between the RA and DA and maintenance of direct control over the implemented projects. Following the beginning of the programme's implementation in 2023-2024, the RA and DA discussed the implementation progress of ISF programme projects, the absorption of funds, problems encountered and possible solutions.

The role of the ISF Monitoring Committee is very important in the monitoring process as it oversees all reports that are submitted to the European Commission, i.e. before its submission to the European Commission the annual balance payment application for the financial year 2024 and final implementation report went through the coordination process.

Difficulties encountered and steps taken to resolve them.

There are procedures established aimed to ensure that the results of the Fund are going to be achieved at reasonable cost. Namely, the DA is assessing the prices indicated in the budgets of projects applications. Together with project application the project promoter has to provide some evidence of market prices, and then has only limited possibilities to deviate from the approved amount. Strict rules on the project budget affecting the frequent amendments of the signed grand agreements.

The minimum allocation requirement is not met only as regards Article 9(2)(c)–(f), where 4% of the basic ISF-B allocation was used instead of the required 5% (SO1.NO3+SO2.NO2+SO2.NO3). Lithuania has focused on SO2 "Borders", NO3 "Common Union standards" (no projects planned under SO1.NO3 and SO2.NO2). However, projects under SO2.NO3 required less funding than originally planned and therefore did not exceed 5%.

Anyway, Lithuania successful applied for the specific action relates to the setting up <u>consular cooperation</u> <u>mechanisms</u> between at least two Member States and carried out a project "Broadening of representation at the Consulate-General of the Republic of Lithuania in Almaty" that has made it possible to ensure high servicing quality, conditions to service larger flows of applicants and increasing the number of represented Member States and at the same time achieve the objectives set out in Article 9(2)(c).
